Its current chairman is Gonzalo Urquijo Fernández de Araoz. After repeated bankruptcies and rescues, it declared in February 20.

Abengoa, S.A. was founded in 1941 in Seville, Spain. The company was listed on the Madrid Stock Exchange in 2012. It was acquired by the private equity firm 80:20 in 2021.

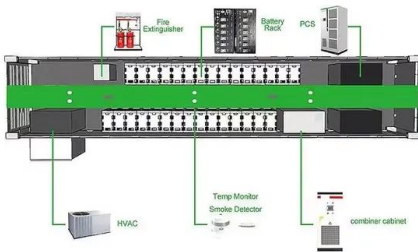

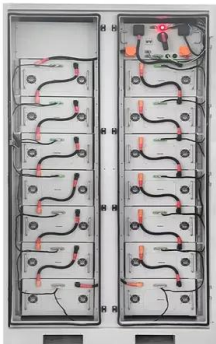

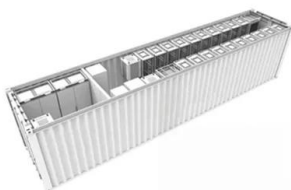
