As per the report, Tata is in the initial stages of talks to establish Agratas Energy Storage Solutions as an autonomous entity. The primary clientele for Agratas's batteries includes Tata Motors and its subsidiary, Jaguar Land Rover Automotive.

Who owns agratas battery?

Agratas is an Indian company that was recently founded by JLR's parent company Tata Group. JLR, the company that used to be known as Jaguar Land Rover, has announced details about its battery sourcing strategy for next-



generation models.

How much will agratas be worth if it goes public?

Such a structure would allow the battery business to raise funds and go public in Mumbai at a later stage, the people said. A listing may value Agratas at \$5 billion to \$10 billion depending on its growth and market sentiment, they said. A representative for Tata declined to comment.
