

# **Are solar panels owned by the state**

Can solar panels be bought outright?

Solar panels can be bought outright, but they are expensive. So many homeowners choose instead to lease out their roof space to solar panel companies. The company will then install the solar panels on the roof, but the panels themselves will remain the property of the company.

Are solar panels legal?

However, it's crucial to understand that while installing solar panels is legal, certain conditions must be met. For most domestic properties, solar panel installations are considered a "permitted development" and do not require planning permission, provided they respect certain size criteria.

Are solar panels allowed under a lease?

The terms of the lease will also need to be carefully reviewed to ensure that installation of solar panels is permitted under the lease. For freehold properties, this is not an issue because the homeowner owns the roof space.

Are the Solar Panels Owned Outright or Not?

Solar panels can be bought outright, but they are expensive.

Are solar PV installations sold between companies?

However, we are aware that in some instances solar PV installations are sold between companies, especially when companies go out of business. This change in ownership may not be communicated to the homeowner.

Do you own solar panels?

You OWN the solar panels. Under these schemes, you pay for solar panels over a fixed period, say 20 years. There are no upfront costs, and instead you pay a monthly fee, which usually covers the solar panel and battery installation, repairs and maintenance.



Can a third party install solar panels on a property?

The most common arrangement is that the third party installs solar PV panels on the property. The homeowner then receives the electricity generated (lowering their electricity bills) and the third party owner of the installation receives any associated subsidies, in this instance, FIT generation and export payments.

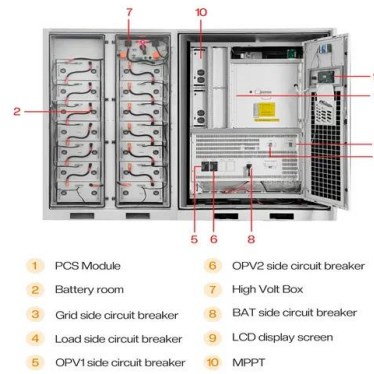

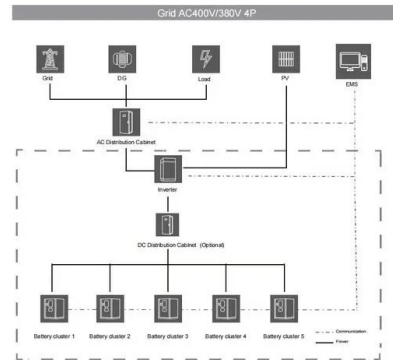
