### REC Registry accounts , Clean Energy Regulator

The Renewable Energy Certificate (REC) Registry is an online system for Renewable Energy Target participants to create, transfer and surrender renewable energy certificates. There are 8 types of REC Registry accounts. Each account has different permissions.

### Supporting renewable energy , Clean Energy Regulator

The Large-scale Renewable Energy Target (LRET) provides eligible power stations with large-scale generation certificates (LGCs) for electricity generated from renewable sources. The Australian Carbon Credit Unit (ACCU) Scheme credits eligible projects with ACCUs for reducing emissions, including by turning waste into renewable substitutes for fossil fuels.

You can buy and sell small-scale technology certificates (STCs) through the STC open market or the STC clearing house. Anyone with a registered person or registered agent account in REC Registry can trade STCs fore trading Create and register your STCs in ...

### **Calculate certificate liability , Clean Energy Regulator**

A liable entity acquired 10,000 MWh of electricity in 2023. The RPP for that year was 18.96%. They have a shortfall of 100 LGCs carried forward from the previous year. Using the formula, their total liability is 1,996 LGCs. The calculation is  $(10,000 \times 18.96\%) + 100$

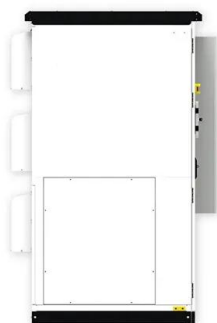

### Small-scale technology certificates (STCs) , Clean Energy Regulator

A 12 month creation period for registered persons to create small-scale technology certificates (STCs) applies under the Renewable Energy (Electricity) Regulations (2001). Data for installations and installed capacity in 2023 and 2024 have been lag-adjusted to account for the 12 month creation rule and are estimates only.

### Voluntary offsetting and surrender , Clean Energy Regulator

Under the Renewable Energy Target, liable entities must acquire and surrender LGCs and small-scale technology certificates (STCs) to comply with their renewable energy obligations. Under the Safeguard Mechanism, safeguard facilities that exceed their emissions baselines must manage the excess, which they can do by surrendering ACCUs or Safeguard ...



### [What is a renewable energy certificate \(REC\)?](#)

Renewable energy certificates From 1 January 2011 RECs were split into types: small-scale technology certificates (STCs) and large-scale generation certificates (LGCs). RECs is still used as a general term covering both STCs and LGCs.
