Overview

The Companies Ordinance expressly prohibits the sole director from acting as the company secretary. Besides, the Companies Ordinance provides that no private company having only one director may have a body corporate as its company secretary if the sole director of that body corporate is also the sole director of the private company. Besides, the Companies Ordinance provides that no private company having only one director may have a body corporate as its company secretary if the sole director of that body corporate is also the sole director of the private company.

Can a sole shareholder be a company secretary in Hong Kong?

The Hong Kong Company Ordinance prohibits the sole director and sole shareholder from being a company secretary. Those three positions must be occupied by distinct entities. In a sole proprietorship, one person can hold the roles of director and shareholder.

Can a private company have a body corporate as its company secretary?

Besides, the Companies Ordinance provides that no private company having only one director may have a body corporate as its company secretary if the sole director of that body corporate is also the sole director of the private company. Do you find this information useful?

Should every company appoint a company secretary?

In addition, every company should appoint company secretary though there is no offence provision for failure to appoint one. 18. For better enforcement of the statutory requirements to have directors and company secretaries, the new CO empowers the Registrar to issue directions to a company to appoint directors and company secretaries.



What is a company secretary?

The company secretary is a company representative who will report to the Companies Registry any change in the structure of a company and its key personnel data (i.e. its directors and shareholders). Be careful not to mix up a “company secretary” with a “secretary” who may only handle clerical duties.

Who is a company secretary in Hong Kong?

Every Hong Kong Company is required to nominate a company secretary under section 154 of the Hong Kong Companies Ordinance, appointed by the company board of directors. The Company Secretary can be an individual who is a Hong Kong resident, or a Hong Kong corporate service provider holding a TCSP License.

FAQ

A private company having only one director must not have a body corporate as its company secretary if the sole director of that body corporate is also the sole director of the private company. A public company or a company limited by guarantee must have a company secretary and at least two directors, one of whom may be the company secretary.

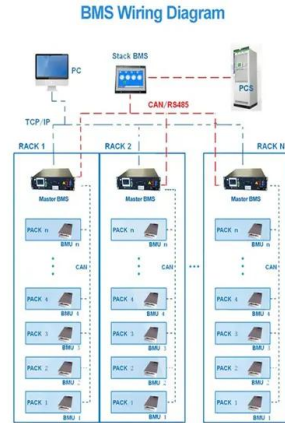

What's the Difference Between a Director and a Company Secretary?

There were originally restrictions that meant sole directors were unable to act as company secretary but this is no longer the case for private companies. Nowadays anyone (within reason!) can be a secretary in a private company, though it's the directors' responsibility to choose someone with knowledge and experience for the job.

How can a Company Sign Under Section 127 of the Corporations ...

To consider an agreement valid, at least two directors must sign it, or a director and a company secretary must sign it, or the company must execute it under its common seal (if it has one). If a company fails to comply with the requirements of section 127, the agreement may not be legally binding.

Corporate Company Secretary Singapore: Price and Duties

The Companies Act has also outlined when an individual cannot serve as a corporate secretary. 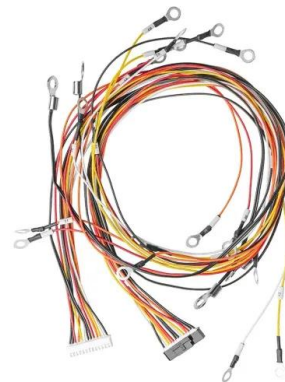

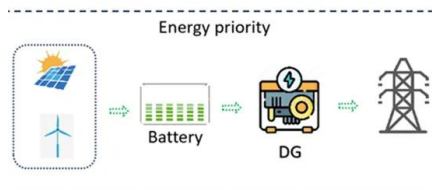
Singapore Company Director and Singapore Company Secretary

The company secretary is required to ensure that the company is in compliance with the relevant legal requirements in accordance with Singapore Companies Act, Cap. 50, including preparing and filing statutory registers and returns, board resolutions, minutes of the general meetings.



The Role of a Company Secretary , 1st Formations

This role can also be held by another company or organisation, the firm's accountant or solicitor, a professional chartered secretary, or a company that provides company secretarial services. However, the role cannot be held by the company auditor, any employee of the auditor, or any person who is an undischarged bankrupt or disqualified director.





Can a sole director also be the Company Secretary?

No, a sole director cannot also act as the company secretary. There must be a clear distinction between the roles to ensure proper checks and balances in corporate governance. However, if a company has more than one director, one of the directors can also be appointed as the company secretary.
