However, there is no specific state law preventing HOAs from restricting solar panels. On the other hand, proposed legislation that could impact HOA solar panel laws in Georgia is also under consideration. Do HOAs have solar access laws?

Laws vary by state, from guaranteeing residents of HOAs the right to put up solar panels to outlining just how far an association can go in controlling the design and implementation of a solar system. ### Can HOA Restrict Solar Panels in South Carolina?

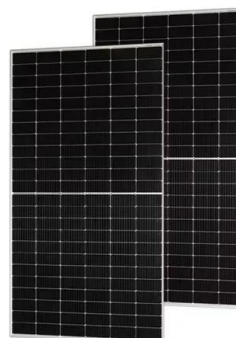

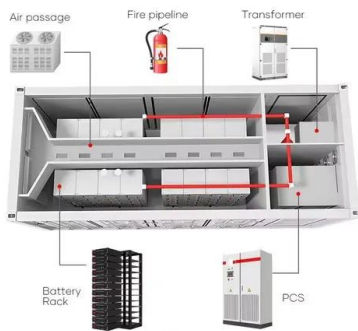

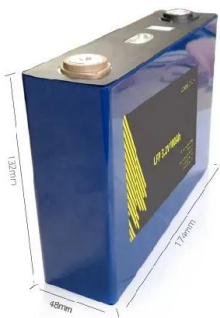
