This credit is nonrefundable, meaning your clients won't get a refund for credit amounts that exceed their tax liability. However, the credit will carry forward into the next tax year. Can a business write off a solar PV system?

Since solar PV systems are considered assets of the business, depreciation deductions can be taken. Businesses may take a combination of bonus depreciation and Modified Accelerated Cost Recovery System (MACRS) to write off the solar PV system. The depreciable base is the total cost of the solar PV system less one-half of the credit amount.

If you installed solar panels, you may be in line for a tax break when you file your return. The U.S. government offers a solar tax credit that can reach up to 30% of the cost of installing a system that uses the sun to power your home. »

The installation of the system must be complete during the tax year. Solar PV systems installed in 2020 and 2021 are eligible for a 26% tax credit. In August 2022, Congress passed an extension of the ITC, raising it to 30% for the installation of which was between 2022-2032.

Can a business take a solar PV tax credit?

The business must have begun or hired a company to begin the construction of a solar PV system before year-end to take the credit. Businesses will need



to file Form 3468 on the tax return to claim the credit. Just like individuals, businesses are also able to take the 30% credit from the Inflation Reduction Act to boost tax savings.

Is the solar tax credit refundable?

No. The solar tax credit can save you money on your tax bill, but the amount of your credit can't exceed the total amount you owe. That's because the credit is "nonrefundable," in tax speak. Put simply, if the credit reduces your overall tax bill below zero, the IRS is not going to cut you a check for the difference.

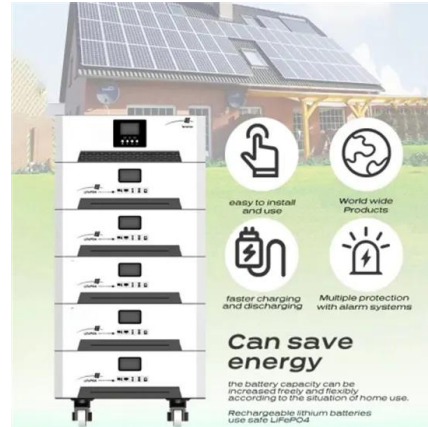


### Solar Panels Tax Deduction for Businesses

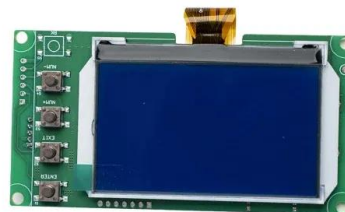

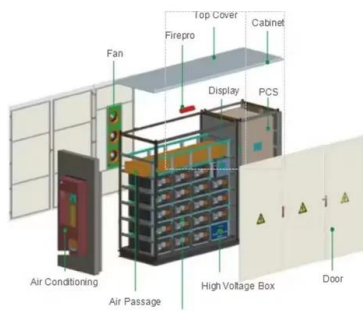

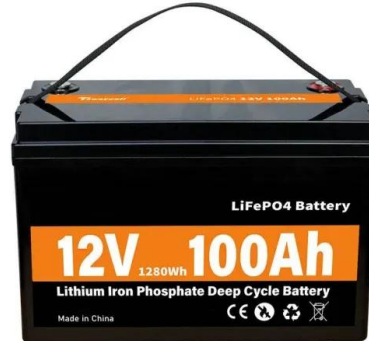
