

# **Company name for sole proprietorship**





## Overview

Sole proprietors can operate under their own names or fictitious names (DBA) as in "John Doe, doing business as Leather World." If you choose the latter option, you must register your business name with the local secretary of state. What is a sole proprietorship business?

Can a business name be used as a sole proprietorship in Hong Kong?

Selected business names are not allowed to use the limited terms related to the public limited company, abbreviations of limited (Ltd) and limited liability partnership (LLP) in their business name. After selecting the appropriate name for your sole proprietorship, business owners can apply for sole proprietorship registration in Hong Kong.

Do sole proprietorships need to register a business entity?

Sole proprietorships are required to register their business entity with the Inland Revenue Department of the Business Registration Office. 4.

Can I operate more than one sole proprietorship in Hong Kong?

If you choose to operate more than one sole proprietorship in Hong Kong, each business will be required to have its unique business name and its own Business Registration Certificate.

What are the naming guidelines for a sole proprietorship?

In this article we provide naming guidelines for the following entity types: A sole proprietorship has no existence separate from its owner. Therefore, the legal or true name of a sole proprietorship is its owner's full name. But if the



business will be operating under a different name, most jurisdictions require that the name be registered.

How to register a sole proprietorship in Hong Kong?

Registering a sole proprietorship in Hong Kong will require you to select an appropriate name for your business before registering with the Inland Revenue Department. You may choose to register your business name in either English, Chinese or both. Chinese business names may include English alphabets but must not contain any English words.
