

# **Customs code for solar power generation equipment**





## Overview

---

The product codes used for the three products shown in this article are: Wind turbines: CN code 850231 Solar panels: CN code 85414300 Liquid biofuels: CN codes 220720, 382600 and 29091910 Can a photovoltaic cell be used for an export declaration?

Can be used for an export declaration. Photovoltaic cells assembled in modules or made up into panels; Examples: - Photovoltaic cells assembled in modules (500 watts, 1200mm x 600mm x 40mm) .

Can a solar panel be a generator under a non-dutiable heading 8501?

Where the import duty involved, Customs has an incentive to challenge the importer when the latter classifies solar panels under a non-dutiable heading 8541. Solar panel, exposed to the sun light, generates DC current, however it is not a generator in terms of 8501 yet.

What if I rely on a commodity code from an overseas supplier?

If you rely on the commodity code from an overseas supplier, you'll need to check if the treatment is the same and how much of the code applies in the UK. How to use the Trade Tariff tool or get help to classify your goods, so you pay the right amount of Customs Duty and import VAT.

Does HMRC pay anti-dumping duty if solar modules originate in India?

Applying the Contested Regulation, HMRC determined that the solar modules originated in China, and calculated anti-dumping duty and countervailing duty accordingly. The Appellant, however, considers that an application of Article 24 would result in the solar modules being deemed to originate in India, so that no such duty is payable.

Which electricity suppliers are required to offer export tariffs?

It requires licensed electricity suppliers to offer export tariffs to anaerobic digestion (AD), hydro, onshore wind, and solar photovoltaic (PV) generators



with a total installed capacity up to 5MW, and micro-combined heat and power (micro-CHP) up to 50kW.
