Can a new leader make democratic progress in Tanzania?

President Samia Suluhu Hassan may be able to engineer this over time, but Chama Cha Mapinduzi's history tells us that doing so will be a long and difficult struggle.

How did politics change in Tanzania?

Beginning in the mid-1980s, under the administration of President Ali Hassan Mwinyi, Tanzania undertook a number of political and economic reforms. In January and February 1992, the government decided to adopt multiparty



democracy. Legal and constitutional changes led to the registration of 11 political parties.

The executive branch in Tanzania is responsible for overseeing the country's economic development, foreign affairs, defense, and internal security. It plays a key role in implementing policies aimed at promoting economic growth, improving living standards, and reducing poverty.

What is Tanzania's political history?
