The government of Indonesia has launched a programme that aims to build 100GW of solar PV and 320GWh of BESS in the coming years, mostly distributed across smaller projects in rural areas. The programme will consist of 80GW of solar PV plants and 320GWh of battery energy storage systems (BESS).

When are exemptions to procurement procedures allowed in Indonesia?

In general, exemptions to the procedures are allowed when certain cases before or during procurement activity are met. Indonesia is not a Party to the WTO Agreement on Government Procurement but has been an observer to the WTO Committee on Government Procurement since October 2012.

How can I challenge a procurement process in Indonesia?

the Indonesia Competition Commission (Komisi Pengawas Persaingan Usaha, or KPPU) if indications of unfair business competition are present. It is also possible to challenge the validity of the procurement process in a civil court by filing a tort lawsuit, which will be examined based on the Indonesian Civil Code and the Indonesian Civil Procedure.

Can a company sell to the government in Indonesia?

Companies seeking to sell to the government should consider getting listed in the e-catalog which must be done via a locally registered Indonesian company. Currently the e-catalog includes mostly heavy equipment, medicine and medical equipment, motorized vehicles, and technology (hardware and software).

What happens if a bidder loses a contract in Indonesia?

The time frames will be set out separately by the Selection Committee in bidding documents. There are no prior hearings in procurement processes in Indonesia. However, losing bidders may submit a refutation after the winner has been announced in the following circumstances:.

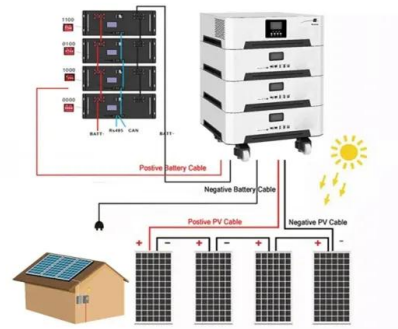

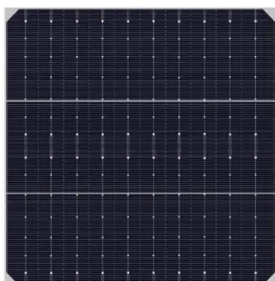

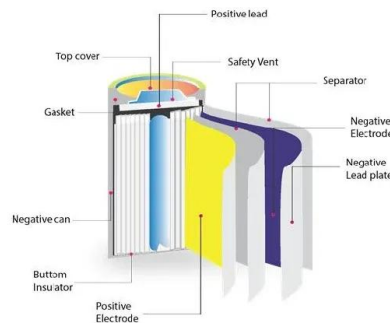
