## Overview

What is public procurement in Estonia?

All contacts in the field of public procurement in Estonia see here. Public procurement means making a purchase by the state or some (as a rule) public sector authority according to the rules specified in the law. Supplies, services or works are purchased as a public procurement.

How does e-procurement work in Estonia?

The central e-procurement platform offers end-to-end services to contracting authorities and bidders free of charge. Public Procurement in Estonia is regulated by the Public Procurement Act (PPA), which transposes EC Directives 2004/17/EC, 2004/18/EC and 2007/66/EC, and governs the awarding process for goods, services, and public works contracts.

Is Estonia a good country for electronic public procurement?

Estonia is at the forefront of electronic public procurement in the EU. 90% of the total number of public procurement notices were electronic, an increase of 10% compared to 2015. The average number of tenderers is higher for electronic procedure (3,7) compared to non-electronic procedures (2,6).

Is e-procurement mandatory in Estonia?

Estonia ranks among the most advanced MS in terms of e-procurement. E-notification has been mandatory since 2001, and compliance is effectively 100% for contracts above EUR 10,000 for goods and services, and EUR 30,000 for public works.

Why is Estonia a good place for foreign SMEs?

By fully adopting and implementing the latest EU common rules on public procurement, supported by the English version of the National Procurement Register and widely used online procedures, Estonia has a good environment for foreign SMEs to participate in its domestic public procurement market.



Does Estonia have a central procurement body?

Estonian law provides for joint procurement, but does not currently feature a comprehensive central procurement body. However, the Centre of Registers and Information Systems does currently operate as the central purchasing body at the state level for IT goods and services.

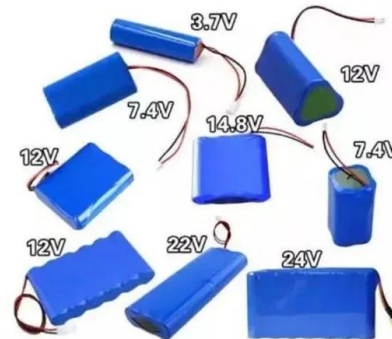

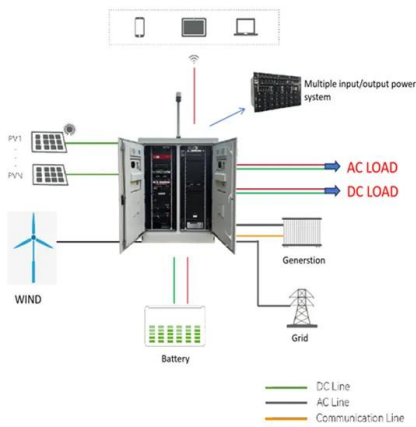

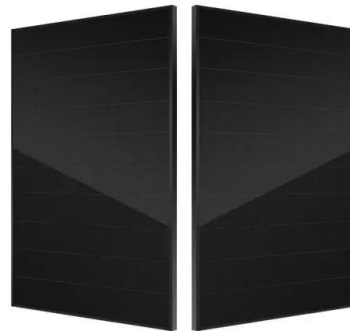
