A separate clean energy Fund called Green Energy Fund of Zimbabwe shall be set up to extend financial assistance for setting up projects relating to new and renewable sources of energy and other sustainable energy projects such as Demand Side Management initiatives.

What are the standards for renewables based off-grid products in Zimbabwe?

All the available renewables based off-grid products shall adhere to the specified quality standards. The regulator along with Standards Association of Zimbabwe (SAZ) have endorsed the International Electro-technical Commission (IEC) standards for solar PV and lighting as national standards for



use in Zimbabwe among others.

What is the best procurement method for biomass energy development?

Small Hydropower: In line with the National Energy Policy (NEP) for small-scale hydropower (less than or equal to 30 MW) procurement is proposed to be through FiT. Biomass: With low variances in costs of equipment and limited competition FiT shall be the ideal procurement method for procuring energy from biomass energy developers.

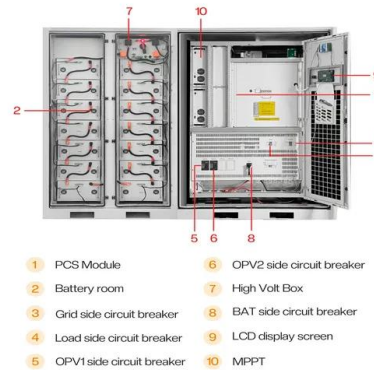

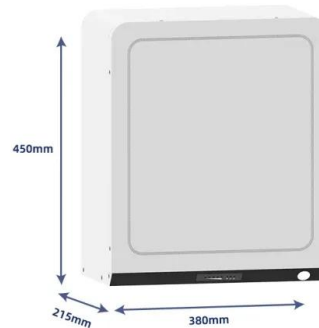

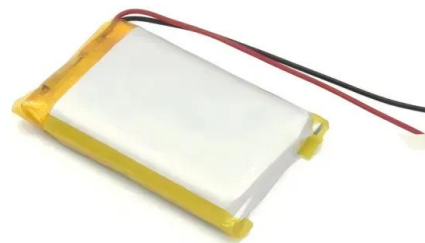
