

# **Gp locum sole trader or limited company**

0 Comments Tweet Most locum GPs operate as what is known as Sole Traders where you, the GP are the business, owner and manager. However a proportion of GPs are operating via Limited Companies (Ltds). In this case, the business is a separate legal entity and the GP is the director who holds all or a proportion of the company's capital. Can a locum work through a limited company?

This eventually means, in most cases, that locums are treated as if they were employees, and therefore your company's income would be treated as your individual income. That means it would be subject to income tax and National Insurance deductions. For this reason, most locums choose not to work through a limited company nowadays.

How can a self-employed locum GP help my business?

As a self-employed locum GP is an essential tool for your business. Not only will it take care of your invoicing and pension work preparation, it will also record all the information you need to stay IR35 compliant and support your self-employed status with the HMRC.

How does a locum doctor work?

The locum doctor can provide their services in different ways, including direct employment, working via a limited company, as a sole trader or even via an umbrella company. And of course, the aforementioned agency route. By providing services through an NHS or locum agency, health workers pay employment tax at source under normal PAYE rules.

How can a locum doctor get paid?

However, there are other ways that locums or freelance GPs can go about finding work and getting paid for their services. The locum doctor can provide their services in different ways, including direct employment, working via a limited company, as a sole trader or even via an umbrella company. And of course, the aforementioned agency route.

Starting a limited company as a Locum Doctor or GP can be a daunting prospect, as it requires a good understanding of business law and financial management. Good practice management will increase the ability of your business to survive over the long term.

What is the difference between a self-employed GP and a sole trader GP?

In contrast, a self-employed (sole trader) GP benefits from much more relaxed expense rules, although they do still have to be wholly and exclusively for business purposes. If your company turnover exceeds £83,000 your business will need to charge VAT on any invoices.

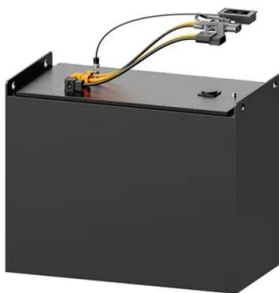

### IR35 & Lantum

Based on our calculations, with an assumed annual income of £100,000 - locums working as a self employed/sole trader will earn £902 more in take home pay, than locums working as a limited company. This suggests that on sessions where PAYE is applied, being a sole trader is the best option for take home pay.



### Tax relief for locum doctors

The limited company's finances are also separate from your own and as such the money you make belongs to the company, and you are paid through the company. Many locum doctors work via agencies and the NHS, which handle their pay and taxes in a similar way to a direct employer, in that they are taxed at source under normal PAYE rules.



### **Should You Locum Through A Limited Company in 2023?**

These days, it's becoming much less common for locum doctors to be paid through a limited company within the NHS, especially at more junior grades. Most locum doctors will be paid through PAYE, where you're paid in a similar way to a normal employee by each Trust, with tax, National Insurance, and pensions deducted automatically by your employer.

### **IR35 changes for GP locums with Ltd companies**

If a locum isn't correctly applying the IR35 rules to their limited company today, they will find themselves paying more tax after the 6th of April. Of course this change has been brought to combat perceived non-compliance of the IR35 rules and so in many cases locums will find that the new rules have the effect of reducing their take home pay.
