Can foreign companies participate in Croatian public tenders?

In accordance with this directive, since the end of 2018, all tenders in Croatia are submitted electronically, complying with the public procurement legislation of the Republic of Croatia including its last amendment. Foreign companies considering participation in Croatian public tenders are welcome to apply.

How much does a procurement cost in Croatia?

- 66.360,00 € for the estimated value of the procurement more than 13.272.000,00 €. Note: The amounts of fees for the initiation of appeal procedures, in which the amounts are stated in euros, are applied as of January 1, 2023, which is the date of introducing the euro as the official currency in the Republic of Croatia.

How important is public procurement in the Croatian economy?

Public procurement plays a crucial role in the Croatian economy, accounting for an impressive 19,98% of the GDP, according to the latest data from the Croatian Bureau of Statistics. This fact underscores the significance of public procurement as a key driver of economic activity in the country.

Who can compete in public procurement procedures in Croatia?

Therefore, all bidders who fulfil the conditions prescribed by the procurement documentation can compete in public procurement procedures in Croatia. The procurement documentation prescribes the criteria for the qualitative selection criteria for economic operator and the criteria for the selection of the bid.

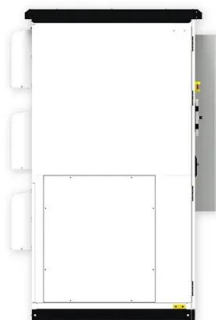

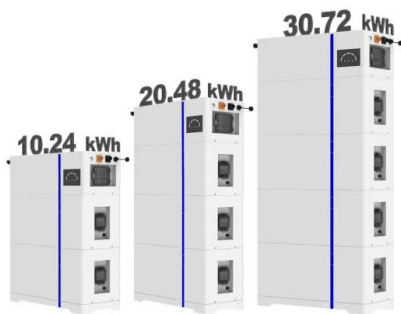
