Will Marubeni build a large-scale battery energy storage system?

Marubeni Corporation will build and own a large-scale battery energy storage system (BESS) on Japan's northern island of Hokkaido.

What is Marubeni's new battery storage subsidiary - Kitahiroshima battery storage?

Marubeni's new subsidiary, Kitahiroshima Battery Storage, will put the energy stored in the BESS to use in a number of different applications. They include the new capacity market, grid-balancing ancillary services opportunities and wholesale power trading, with the Kitahiroshima project among those to avail of government subsidies.

Is Marubeni a sustainable company?

As evidenced by the Notification Regarding Business Policies Pertaining to Sustainability in Relation to Coal-Fired Power Generation Business and Renewable Energy Generation Business (*4) issued in September of 2018, Marubeni is committed to being involved in renewable energy projects in MENA and around the world.

What will Marubeni do with skeleton?

Marubeni will start to work on sales of Skeleton's ultracapacitors and develop the use cases and markets of its next generation energy storage technology with Skeleton in Japan and other Asian countries. In the global fight against climate change, in October 2020, Japan's Prime Minister declared the country will become "Carbon Neutral by 2050".

How does Marubeni manage supply and demand?

This allowed Marubeni to, among other things, internally balance the supply and demand of power retail sales through power sourced from Marubeni-owned plants. Marubeni has thus accumulated ample skill in supply-and-



demand management and has an impressive track record of power projects.

What does Marubeni do for the hydrogen energy supply chain?

In 2018 Marubeni participated in the Hydrogen Energy Supply Chain pilot project between Australia and Japan and then joined the CO2-free Hydrogen Energy Supply-chain Technology Research Association (“HySTRA”).
