

Notice of independent solar energy producer contract





Overview

An independent solar energy producer contracting for the use or sale of electricity or the lease of a solar energy system, to an entity or person, for use in a residence shall record a Notice of an Independent Solar Energy Producer Contract, within 30 days of the signing of the contract, against the title to the real property on which the electricity is generated, and against the title to any adjacent real property on which the electricity will be used, in the office of the county recorder for the county in which the real property is located. Who owns a solar plant?

With few exceptions, the seller is a special purpose entity (often called an “SPV” or the “project company”) that owns and operates the solar plant that will generate energy and environmental attributes (“output”).

Does Tesla transfer a solar agreement to a new owner?

When Tesla customers sell their homes, we transfer the solar agreement to the new owner ~98% of the time. In a small number of cases our customers elect other options as outlined in their agreement. When should I initiate the home sale process with Tesla?

The home sale process should be initiated as soon as you are in contract with a buyer.

Can a PPA buy a solar project?

Buyer Options to Purchase the Project or Special Purpose Entity. Many utilities have shown a strong interest in owning solar energy projects. In PPAs, this interest often takes the form of an option to purchase the project or the entity that owns it on or after a specified date. Such options should be handled carefully.

How does a solar agreement transfer work?

The seller submits a request to initiate the solar agreement transfer with the buyer, including escrow details. The assuming party is contacted to review the



obligations of the agreement and address any other questions. The transfer agreement is sent to both the assuming party and the seller for signatures via AdobeSign.

Can a PPA be terminated if a solar project is unreliable?

D. Termination Rights. To protect against chronic problems at an unreliable solar plant, the PPA may allow the buyer to terminate the PPA if the output or mechanical availability of the project is below a stated minimum for a certain number of years. How do solar projects work?

As a result, the standard model for solar projects is to have some sort of output agreement that either provides for the long-term sale to a utility of the energy output (and typically associated environmental attributes) at a specified price or provides a hedge against the price volatility inherent in the spot market.

What role do independent power producers (IPPs) play in the energy

IPPs can be corporations, cooperatives like rural solar or wind energy producers, privately held facilities, and non-energy industrial concerns that can feed their excess energy into the system. The excess power can be bought by utilities or end users to bring passive income to the solar IPP and ensure that solar energy is not being wasted.

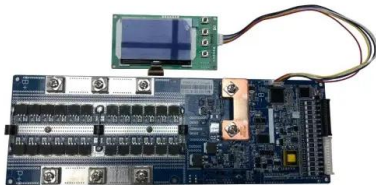
