

# **Photovoltaic brackets exported to Australia**

Will Australians be able to charge solar panels for exporting electricity?

(Supplied: Solahart) Power companies will soon be able to charge Australians with rooftop solar panels for exporting electricity to the grid, under new rules introduced by the Australian Energy Market Commission (AEMC). The plan to allow export tariffs was flagged in a draft determination in March, with a final decision handed down on Thursday.

What is flexible exports for solar PV?

The “Flexible Exports for Solar PV” project (‘the Project’) is a collaboration between SA Power Networks, AusNet, Fronius, SMA, Solar Edge and SwitchDin. The Australian Government, through the Australian Renewable Energy Agency (ARENA), is providing \$2.09m towards this \$4.84m project under its Advancing Renewables Program.

What are the new solar export bans in Victoria?

The new rules will prevent network companies from putting blanket bans on that occurring. "You're seeing in Victoria these export bans when people want to connect to the grid, they're told they can't connect anything," Mr Barr said. "We're worried that solar is going to waste.

Source: CSIS With 99 per cent of Australia’s solar panels imported, there is only one manufacturer – Tindo Solar, an Adelaide-based company that



assembles solar panels using imported silicon cells. The Federal Government is keen to increase the capacity of local manufacturing to capture a bigger market share.

Do solar retailers offer flexible exports?

Solar retailers and installers typically align to a small number of inverter brands that are embedded into their sales and installation processes. Having limited solar equipment compatible with the Flexible Exports trial meant that a large proportion of solar retailers could or would not offer Flexible Exports to their customers.
