Overview

What happens if a solar PV company goes out of business?

How to deal with solar PV waste material?

Therefore, the methods of dealing with solar PV waste material, principally by recycling need to be established by 2040. By recycling solar PV panels EOL and reusing them to make new solar panels, the actual number of waste (i.e., not recycled panels) could be considerably reduced.

Does solar PV panel EOL management exist?

Therefore, solar PV panel EOL management is an evolving field that requires further research and development. The key aim of this study is to highlight an updated review of the waste generation of solar panels and a sketch of the present status of recovery efforts, policies on solar panel EOL management and recycling.

Do solar panels need to be removed?

When customers sign a solar lease or power purchase agreement (PPA), the solar company agrees to cover the cost of the panel removal when the lease is up, usually after 20 years. But big companies like SunRun assume that 90% of customers will renew their agreement and keep their panels, according to a report by the research firm Muddy Waters.

Are big companies accounting for the cost of removing solar panels?

The idea that big companies aren't accounting for the cost of removing panels from homes is a theory that Pol Lezcano, senior associate at BloombergNEF, finds believable. Big companies use their cash "to originate and sell new



systems,” he says. “I doubt they are planning to have cash aside to remove panels when contracts expire.”.

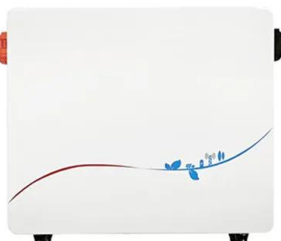

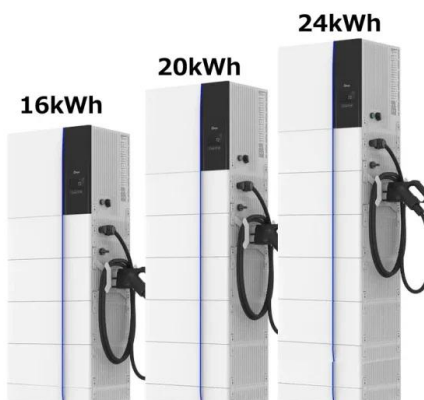

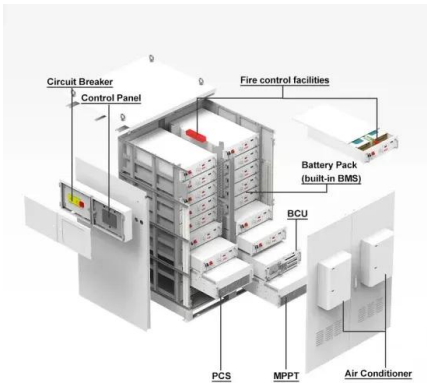
