Corporate Governance From the time of listing, an issuer is required to establish a strong corporate governance framework to facilitate its compliance with the GEM Listing Rules and adherence to proper business practices. Role of the Exchange At the time of listing, the Exchange reviews the listing documents of an applicant.

What is gem & how does it work?

GEM is for small and medium sized business. It has lower listing eligibility criteria, but similar continuing obligations compared with the main board. Greater Disclosure Following listing, GEM issuers are required to make half yearly comparisons of business progress against their business plan for the first two financial years. GEM Sponsor Scheme.

Why should International Growth Companies list on GEM?

As well as the listing of local and regional enterprises, international growth companies can also enhance their business presence and raise their product profile in Mainland China and Asia by listing on GEM. GEM is for small and medium sized business.

How to search gem documents?
