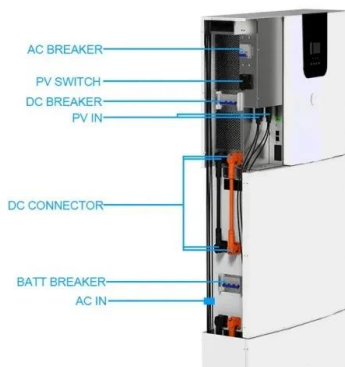

### Revision of the Renewable Energy Directive: Fit for 55 package

The trilogue negotiations were concluded on 30 March 2023 with an agreement raising the share of renewables to 42.5 % by 2030. The revised directive (RED III) was published in the Official Journal on 31 October, and entered into force on 20 November 2023

Renewable Energy - Recast to 2030 (RED II)

Renewable electricity will count 4 times its energy content towards the 14% renewable energy in transport target when used in road vehicles, and 1.5 times when used in rail transport. The Commission will also develop a framework to guarantee that the renewable electricity used in transport is in addition to the baseline of renewable electricity generation in each Member State.

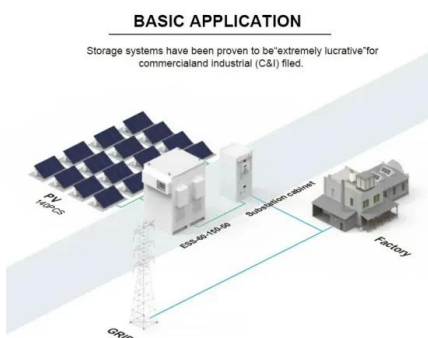

## Renewable Energy Directive , Think Tank , European Parliament

The revised Renewable Energy Directive will set a target of a 42.5 % share of renewables in EU energy consumption by 2030, with additional sub-targets for some sectors. A provisional agreement was reached with the Council in March 2023 and Parliament is due to vote on the text during its September 2023 plenary session.
