In 2024, Panama solar power capacity saw the installation of 0.743 GW, marking a growth rate of 15.01% compared to the previous year. As a result, the total Panama renewable energy capacity has reached 24.76 % of the Panama's energy mix. In the last decade, solar power capacity has grown.

Incentives available for solar projects in Panama at present include an exemption from import tax, as well as the ITMBS (VAT) for the import or local purchases of equipment, parts or materials necessary for the construction, maintenance and operation of solar projects. Projects can also receive a.

The National Assembly of Panama adopted Law 417, published on 27 December 2023, which revises Law 37 of 2013 and broadens the incentive framework for the solar power sector. New incentives include tax exemptions and import duty reliefs for all individuals and entities involved in the solar.

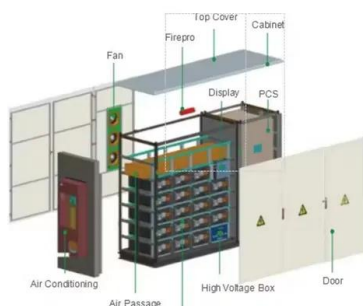
