How does the solar rebate work? , South African Revenue Service

The solar energy tax credit applies to the 2024 YOA only and the amount allowed as a deduction will be 25% of the cost of the above solar PV panels up to a maximum of R15 000. Note: batteries, inverters, fittings or diesel generators, installation costs and portable panels do not qualify.
