

Solar panel rebate victoria





Overview

As a Victorian householder, you could receive a solar panel (PV) rebate if: 1. you are the owner-occupier of an existing property or the owner of a home under construction where the system is to be installed 2. combined household taxable income of all owners is less than \$210,000 per year 3. value of the property is under.

If you think you are eligible, follow the step-by-step process: 1. Do some research – read our Solar Panel (PV) Buyers Guide 2. Talk with.

You can apply for a solar panel rebate while your house is being built. Talk to your builder early – preferably during the planning phase to: 1. discuss your preference for solar 2. get.

You will be offered an interest-free loan of up to \$1,400 in your application. No collateral is required. If you opt in for the loan, the amount will be processed along with the rebate payment.

Can you get a solar panel rebate in Victoria?

Solar panel rebates of up to \$1,400 plus the option of an interest-free loan are available for existing homes and homes under construction. This expansion of eligibility follows the lift to the income threshold for rebates to \$210,000 per household – ensuring more than 85 per cent of Victorian homeowners are eligible for a rebate.

How much is a Sola panel rebate?

Sola panel rebates of up to \$1,400 are available for eligible Victorians with existing homes, homes under construction and rental properties, with the option to apply for an interest-free loan for an amount equivalent to their rebate. Eligible Victorians who have previously received a rebate and have moved house can still apply.

Can I get a solar panel rebate while building a house?

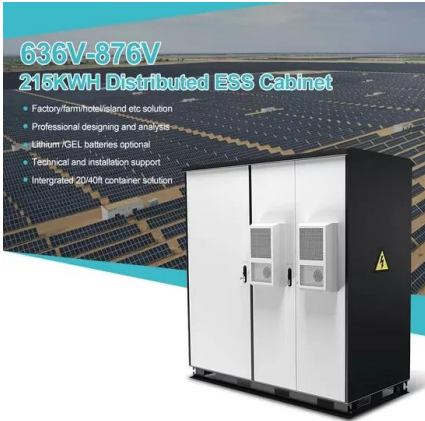
You can apply for a solar panel rebate while your house is being built. Talk to your builder early – preferably during the planning phase to: submit the rebate application at the right stage of construction. Homes that are under construction are not eligible for any other Solar Homes Program rebates or loans.

When can I apply for a solar home rebate?

submit the rebate application at the right stage of construction. Homes that are under construction are not eligible for any other Solar Homes Program rebates or loans. You may be eligible for other rebates when construction is complete. All solar panel (PV) installations must be completed by an authorised solar installer.

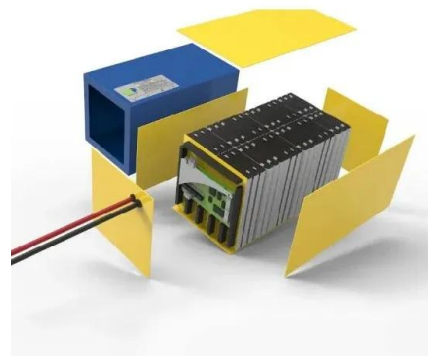

In August 2018, the Victorian government announced their state-level rebate scheme for solar panels, part of the 'Solar Homes Package'. The value of this Victorian rebate as of October 2024 is 'up to' \$1,400 or 50% of the price, whichever is lowest.
