

# Solar power illegal in florida

Does Florida have a rooftop solar Bill?

In 2020, Florida electric utilities reported 90,552 customer-owned rooftop solar connections, nearly one-third more than in 2019. Under the bill, rooftop solar owners will be given a credit at current retail rates for the energy they



generate and sell back to the grid for the utility to use only through 2024.

Do you need a permit to install solar panels in Florida?

The inspection must be completed before the system is connected to the grid, and any necessary repairs or adjustments must be made before the system can be turned on. Another important aspect of Florida's solar laws is the process of obtaining a permit to install a solar panel system.

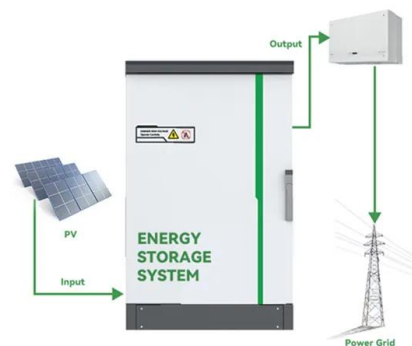

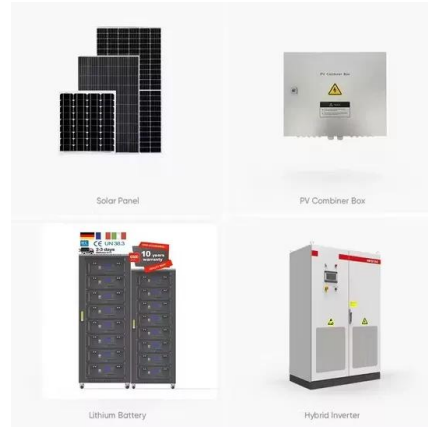
