## Overview

A solar power purchase agreement (PPA) is a financial agreement where a developer arranges for the design, permitting, financing and installation of a solar energy system on a customer's property a. What is a solar power purchase agreement (PPA)?

Individual homeowners can also enter into PPAs. For example, solar power purchase agreements (SPPA) allow individuals to host solar projects, such as a photovoltaic (PV) system with solar panels, on their property with no upfront costs.

Do solar projects need an EPC contract?

In our experience, most utility-scale solar projects use an EPC Contract. An operation and maintenance agreement: This is usually a medium- to long-term Operating and Maintenance Agreement (O&M Agreement) with an Operator. The term of the O&M Agreement will vary from project to project.

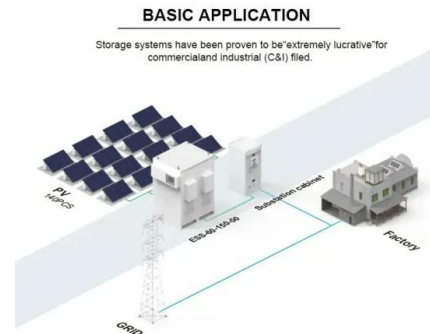

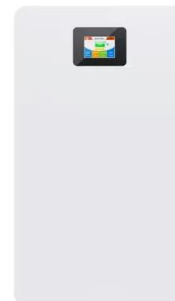
