The predetermined price is called the “strike price,” similar to a call option on a company’s stock. American stock warrants can be used anytime within the allotted term, including on the expiration date, while European warrants can be exercised on the expiration date. 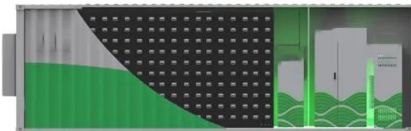
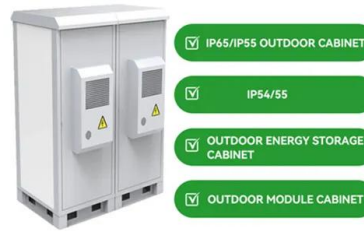
