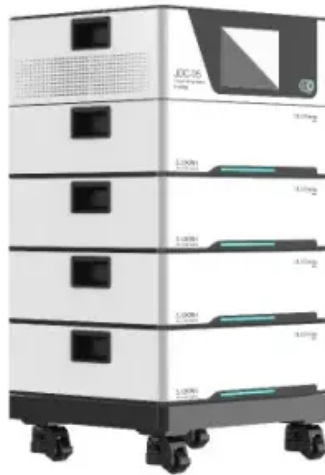


# **Turnkey residential ESS EPC contract price in Ethiopia**

What are the conditions of contract for EPC/Turnkey Projects?

The paper discusses the conditions of contract for EPC/turnkey projects, emphasizing the necessity of balanced risk-sharing between the Employer and Contractor. It outlines how recent market demands have led to a contract structure that requires the Contractor to assume broader risks to ensure price certainty for Employers.

What is a turnkey project?

Under the usual arrangements for turnkey projects, the Contractor carries out all the Engineering, Procurement and Construction (EPC): providing a fully-equipped facility, ready for operation (at the “turn of the key”). Short Form of Contract, which is recommended for building or engineering works of relatively small capital value.

What is a test after completion in an EPC Turnkey project?

Clause 12 Tests after Completion Sub-Clause 12.1 Procedure for Tests after Completion In an EPC turnkey project, the Contractor is typically required to prove the reliability and performance of the Plant during the Tests on Completion, and the Works are only taken over after successful completion of these tests.

How do you negotiate a turnkey project?

Major turnkey projects may require some negotiation between the parties. Having studied the variety of options offered by tenderers, the Employer may consider it essential to meet and discuss with them the technical options which the Employer considers preferable.

What is a taking-over certificate in a turnkey contract?

Clause 10 Employer’s Taking Over Sub-Clause 10.1 Taking-Over Certificate If the Works are to be taken-over in stages, which is unusual under a turnkey



contract, these stages should to be defined as Sections, in Clause 1 of the Particular Conditions. Precise geographical definitions are advisable.
