Overview

Does Washington State have a solar energy program?

As of June 2021, the program is fully subscribed, and is no longer taking new applicants. More information can be obtained from the WSU Energy Program. Washington provides a sales tax exemption for solar energy systems, such as rooftop solar panels.

Does Washington have a solar rebate program?

Washington's one other big solar rebate is known as the Renewable Energy System Incentive Program. While RESIP is still an active program, it reached full capacity in 2021 and is no longer taking on new customers. The Washington State Legislature would need to authorize additional funding for the program to open up again.

How much does community solar cost in Washington State?

Washington state residents can subscribe to community solar through their electricity utility. Puget Sound Energy allows customers to sign up for \$20 per month, but in return, they get bill credits for the solar energy generated by their share. Community solar doesn't always save you money.

Are solar panels tax deductible in Washington State?

Benefits for installing solar panels include sales tax exemption from Washington State for qualifying solar equipment (ESS Senate Bill 5116). From July 2019 and through December 2029, equipment for solar energy systems



smaller than 100 kilowatts is exempt from state and local sales and use taxes.

Can you get a loan for solar panels in Washington State?

If you're planning on financing your solar panels, a couple of loan programs in the state can help make it more affordable. One offering is the Washington State Housing Finance Commission's EnergySpark Home Loan. Customers buying a home can apply for an EnergySpark mortgage with a reduced interest rate.
