What are China's investment guidelines for solar PV projects?

BEIJING, Nov 20 (Reuters) - China's industry ministry on Wednesday finalised investment guidelines for solar photovoltaic (PV) manufacturing projects in an effort to rein in overcapacity, according to a notice on the ministry website. The guidelines direct companies to ensure a minimum capital ratio of 30% for solar PV projects.

What is the VAT rate for PV systems?

The actual VAT rate for Photovoltaic (PV) systems is 8.5%, with a subsidy standard of \$ 0.0678/kWh including tax according to the entire electricity quantity subsidy policy. Capacity increases have been made.

With effect from 1 April 2012 for corporation tax and 6 April 2012 for income tax, all capital expenditure on the provision of solar panels is specifically designated as special rate. The reason for designating solar panel expenditure as special rate expenditure was to ensure clarity of treatment.

How much energy does Xiaomi use a year?

This year, the increase in total energy consumption is mainly due to the launch of Xiaomi's automobile business line, including the direct and indirect energy consumption of the automotive factory of 14,638.78 MWh and 37,068.28 MWh, respectively.



What is the minimum capital ratio for solar PV projects?

The guidelines direct companies to ensure a minimum capital ratio of 30% for solar PV projects. Previously, that standard applied only to polysilicon manufacturing projects while the minimum for other PV projects was 20%.

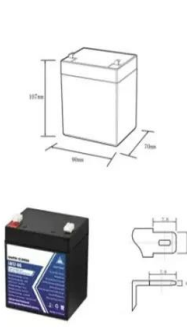

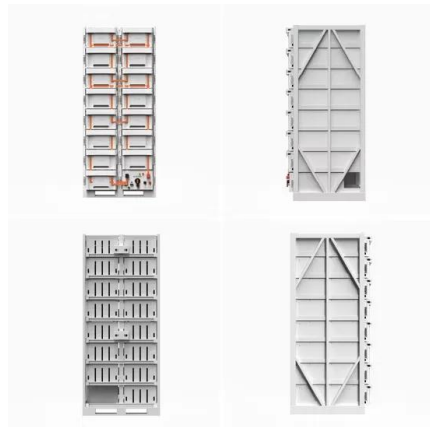
